

LANCASTER BOARD OF SELECTMEN REGULAR MEETING MINUTES OF August 7, 2017

I. CALL TO ORDER

Chairman Stanley B. Starr, Jr. called the Regular Meeting of the Board of Selectmen to Order at 5:30 P.M. in the Lancaster Community Center, 39 Harvard Road, Lancaster, Massachusetts. Present were Selectmen Walter F. Sendrowski, Mark A. Grasso, Jr., Town Administrator Orlando Pacheco and Executive Assistant Kathleen Rocco.

II. EXECUTIVE SESSION

Chairman Starr Moved to go into Executive Session M.G.L. c.30A, Sec. 21(a) #6 – to consider the purchase, exchange, lease or value of real estate, if the chair declares that an open meeting may have a detrimental effect on the negotiation position of the public body and to reconvene back into open session. V. TOWN ADMINISTRATOR'S REPORT

Town Administrator Orland Pacheco had only two items to update the Board on:

1. <u>Devonshire & Eagle Ridge</u>: The Orders of Taking will be ready by next week; the Orders will need to be signed no later than August 29th. He noted that the final "As-Builts Drawings" have been submitted to the attorneys for their review.

2. Surplus Property: Town Administrator Pacheco stated that the Board of Selectmen has been looking for a mechanism to deal with the surplus property, (in which many are land of low value), that the Town has. He noted that the Town has signed up for Gov.Deals account; which provides services to government agencies to allow them to auction surplus property. He further stated that this does satisfy the procurement requirements for land of low value under Chapter 30B. Mr. Pacheco hopes that within the next 60 days to start unloading some of these smaller parcels. He stated that there are 10 parcels that are ready for surplus currently, and expects that number will be higher.

VIII. ADMINISTRATION, BUDGET, AND POLICY

1. Discussion on the Meals' Tax for the Town of Lancaster.

Chairman Starr asked to consider to have the local option of a Meals tax as an article on the Special Town Meeting Warrant, scheduled for early October. He noted that the addition of a meal tax would bring a potential \$43,000 in added revenue to the Town.

Town Administrator Pacheco recommended to the Board of Selectmen to also consider an article on the lodging (room occupancy/hotel) tax at the Fall Special Town Meeting as well.

2. Review and discuss Town of Lancaster Vehicle Policy.

Town Administrator Pacheco presented the Board of Selectmen a draft Vehicle Policy for their review and consideration. He noted that Town needs to have a policy to establish guidelines and standards for vehicles used by town employees. He stated that currently there is no policy in place, and guidelines will avoid discrepancies in the future and establish a clear policy, rules and responsibilities.

Selectman Sendrowski commented that the policy is comprehensive and very detailed.

3. Review and take action on Department of Public Works Superintendent's Contact.

Fire Chief Hanson noted that the Write-offs presented to the Selectmen are in the amount of \$55,689.77, and are deemed uncollectable. He further noted that this is the smallest amount of write-off they have had, and these go back four (4) years.
