

# LANCASTER BOARD OF SELECTMEN REGULAR MEETING MINUTES OF SEPTEMBER 5, 2017

## I. CALL TO ORDER

Chairman Stanley B. Starr, Jr. called the Regular Meeting of the Board of Selectmen to Order at 5:30 P.M. in the Lancaster Community Center, 39 Harvard Road, Lancaster, Massachusetts. Present were Selectmen Walter F. Sendrowski, Mark A. Grasso, Jr., Town Administrator Orlando Pacheco and Executive Assistant Kathleen Rocco.

King, Jr. voted Aye, Douglas A. DeCesare abstained, Stanley B. Starr, Jr. abstained, Walter F. Sendrowski abstained and Mark A. Grasso, Jr. abstained. Motion fails.

Selectman Grasso moved to appoint Courtney Manning as Department of Public Works Commissioner. Selectman Sendrowski Seconded. John J. King, Jr. abstained, Douglas A. DeCesare vote Aye, Stanley B. Starr, Jr. vote Aye, Walter F. Sendrowski vote Aye and Mark A. Grasso, Jr. vote Aye. Motion passes.

6:05 P.M. Pole Hearing: National Grid Petition for a Joint or Identical Pole Locations – Prescott Street.

Chairman Starr opened the Public Hearing at 6:05pm.

Selectman Sendrowski read the following legal notice into the Minutes:

Under the provisions of Chapter 166, Section 22 of the General Laws, and any additions thereto or amendments thereof, a Public Hearing is scheduled for Tuesday, 6:05 pm on September 5, 2017 in the Lancaster Community Center Meeting Room, 39 Harvard Road, Lancaster, MA to consider a petition submitted by National Grid, requesting permission to install, remove and relocate 1 JO Pole on Prescott Street beginning at a point approximately 50 feet Northwest of the centerline of the intersection of Maple St and Prescott St. and continuing approximately 80 feet in a Southeast direction. National Grid to relocate P 10, 40'NW of old Pole 10 and install new Pole 9-50, 35'SE of old Pole 10. National Grid to install anchors on both new poles

# 3. Website

The Town's new website format is live and working well. Appropriate staff have been trained and there have been no integration issues to date.

#### 4. SeeClickFix

Town Administrator Pacheco reported that he has been exploring the possibility of bringing SeeClickFix into Lancaster. This is a cloud based program that will allow residents to take pictures of items in the community and report them to the Town immediately. Items like potholes, sidewalks, streetlight outages, etc. Since I-Phones and Droid devices are now very commonplace, the program would be available to a large segment of the population. Based on initial discussions the cost would be approximately \$8,000.

## 5. Solar Farm Maintenance

The Solar Farm was done recently for maintenance. Greenskies, along with 3C Electrical came out to test the entire site, including the transformer. No additional maintenance should be needed for the rest of the fiscal year and all systems performed as expected.
