

### LANCASTER BOARD OF SELECTMEN

## Regular Meeting Minutes Of October 15, 2018

#### I. CALL TO ORDER

Chairman Stanley B. Starr, Jr. called the Regular Meeting of the Board of Selectmen to Order at 6:00 P.M. in the Nashaway Meeting Room, located in the Prescott Building, 701 Main Street, Lancaster, Massachusetts. Present were Selectman Walter F. Sendrowski, Town Administrator Orlando and Executive Assistant Kathleen Rocco. Selectman Grasso was unable to attend the meeting.

#### VI. TOWN ADMINISTRATOR REPORT

#### 1) Netflix Filming

Netflix will continue it's filming in Town and Wednesday (10/17) will be a heavy traffic day. Please expect limited parking and heavy traffic around the Town complex. Town Administrator noted that there is parking reserved for employees that day.

#### 2) Electronic Billboards

Clear Channel has expressed an interest in developing some electronic billboards in the Route 2 corridor. Mr. Pacheco stated that he had a discussion with them regarding their "Host Community" agreements. A double sided billboard will generally have a \$25,000 annual payment to it along with some free advertising time for the Town.

#### 3) Town Forest Committee

The Town Forest Committee voted to plan for an additional harvest in accordance with the Forest Management Plan. Town Administrator noted that he will start to prepare the bid documents and schedule an update from the Forest Committee at a future meeting. The link

#### 5) Pellechia Boat Launch

The Department of Fish and Game (DFG) has scheduled the bid opening for November 20, 2018. The project has been fully permitted and the DCR have given a Notice to Proceed.

#### 6) COA Van Parking

I am working on developing a plan to utilize the Town Owned parcel on Packard Street to build a small structure to allow for COA Van parking

#### 7) FinCom Calendar

Attached is the approved calendar from the Finance Committee. Mr. Pacheco reported that he will take over the Capital Plan to allow the Finance Director and Finance Committee to spend more time reviewing the Operating Budget.

#### 8) Halloween on the Green

The Lancaster Recreation Committee will be hosting the Halloween on the Town Green again this year. The Town Hall will be open and Mr. Pacheco will make sure Police/Fire Departments are aware of the event.

North Lancaster, LLC's First Amendment to Land Confirmation, Acquisition & Use Agreement Attorney Tom Bovenzi came before the Board regarding the First Amendment to Land Confirmation, Acquisition & Use Agreement for his client North Lancaster LLC. He noted that some of the wording was modified with the Conservation Commission.

3. Review and discussion on Guideline for the Senior Citizen Property Tax Work-Off Program
Town Administrator Pacheco discussed the changes being made in the Guideline for the Senior
Work-Off Program. He noted that there are fundamental differences between the eligibility
guidelines from the State and Town requirements. Council on Aging members Michelle
MacDonald and Nicole Kanis were present for the discussion, noting their concern for that the
current guidelines were too low.

Selectman Sendrowski moved to table the discussion on the Guideline for the Senior Citizen Property Tax Work-off Program. Chairman Starr Seconded. Walter F. Sendrowski vote Aye and Stanley B. Starr, Jr. vote Aye. [2-0-0]

The Board of Selectmen reviewed the survey conducted in the surrounding communities regarding the fees for a Special One Day License. Currently, the Town of Lancaster fee for a One Day Special License is \$25.00 for Beer and Wine.
