

LANCASTER BOARD OF SELECTMEN REGULAR MEETING MINUTES OF February 20, 2018

I. CALL TO ORDER

Chairman Stanley B. Starr, Jr. called the Regular Meeting of the Board of Selectmen to Order at 6:00 P.M. in the Nashaway Meeting Room, located in the Prescott Building, 701 Main Street, Lancaster, Massachusetts. Present were Selectmen Walter F. Sendrowski, Mark A. Grasso, Jr., Town Administrator Orlando Pacheco and Executive Assistant Kathleen Rocco.

IV. TOWN ADMINISTRATOR'S REPORT

Town Administrator Pacheco updated the Selectmen on the following:

1. Revolutionary War Memorial Grant

The Town was awarded a \$12,500 grant from the Massachusetts State Historical Records Advisory Board. The funds will be used to build and install a monument honoring those who served in the Revolutionary War from Lancaster.

2. Water Project Upgrades

The project is out to bid and the bid opening is scheduled for March 7th. The Scope is to replace mater mains on Parker Road, Charlotte, Bull Hill Road and parts of North Main Street (Route 117). The engineers' estimated cost is expected to be in range of \$4 Million, which was approved by Town Meeting. The Treasurer/Collector is aware and is working on preparing the borrowing.

3. Town Forest Landowner Consent

The Snowriders of the Nashaway would like permission from the Town to construct a bride and kiosk in the Town Forest. The Landowner Consent would be used as part of a grant application. The Town Forest Committee has met and supported the project.

4. ATM Zoning Articles

The Planning Board will be submitting revisions to the following zoning articles for the May Annual Town Meeting:

- Amendment to the Lighting Section in the Zoning Bylaw change the allowable color temperature to a more realistic, sustainable range
- Amendment to the Solar Section in the Zoning Bylaw give more Planning Board discretion for waiving or modifying certain requirements.
- New Recreational Marijuana Section in the Zoning Bylaw all for recreational marijuana establishments, but not retain establishments.
- New Recreational Marijuana General Bylaw Town Counsel recommends that there be both a zoning and general bylaw for the recreational.

The Planning Board will be posting the necessary public hearings required.
