

LANCASTER BOARD OF SELECTMEN REGULAR MEETING MINUTES OF JUNE 5, 2017

I. CALL TO ORDER

Chairman Stanley B. Starr, Jr. called the Regular Meeting of the Board of Selectmen to Order at 6:00 P.M. in the Lancaster Community Center, 39 Harvard Road, Lancaster, Massachusetts. Present were Selectmen Walter F. Sendrowski, Mark A. Grasso, Jr., Town Administrator Orlando Pacheco and Executive Assistant Kathleen Rocco.

II. PUBLIC COMMENT PERIOD

6:00 P.M. Opportunity for public to address their concerns, make comment and offer suggestions on operations or programs, except personnel matters. Complaints or criticism directed at staff, volunteers, or other officials shall not be permitted.

Barbara Belisle, 1427 Main Street, came before the Board of Selectmen to express her concerns regarding the Annual Town Meeting. She noticed that he Moderator was using total registered voter counts for the $2/3^{\rm rd}$ votes. In her opinion, it should not have been used, since some of the voters attend these meetings with their own agenda. She further noted that the previous Moderator always gave the audience the actual counts for the $2/3^{\rm rd}$ votes and would like to continue. She asked the Selectmen if Robert's Rules of Order were used at the Town Meetings.

Chairman Starr noted that the Town of Lancaster have never adopted Robert's Rules.

III. SCHEDULED APPEARANCES & PUBLIC HEARING

6:10 P.M. COA Director Alix Turner will update the Board on the Healthy Food for Every Age Grant – Sponsored by Harvard Pilgrim Health Care Foundation.

The Lancaster Community Center and Council on Aging has received a \$10,000 grant from the Harvard Pilgrim Health Care Foundation to support the "growth" of the Get Dirty Gardening Program and the Center Village Table. COA Director Alix Turner explained that this is a multi-faceted project pairs seniors and children and families of all ages in a true community garden project. Gardeners share not only produce but also learning and growing knowledge, as well as working and tending together. Other benefits of this project include the social impact, where friendships are reducing social isolation and some gardeners have developed an appreciation for skills of other generations and people.

Ms Turner stated that the shared produce is used in the Council on Aging lunch program and for all ages events. It is also used in cooking classes and tastings. This year, the Get Dirty Gardens will expand to add some non-traditional additions, including a "fun garden" with bean and squash tee-pees, magic pumpkin

patch and more. Cooking and learning classes will be shared via YouTube and other social media. Finally, she noted that they have the support of local chefs and farms who will be joining LCC and Council on Aging for the Center Village Table, A Farm-to-Fork dining series.

IV. TOWN ADMINISTRATOR'S REPORT

Town Administrator Orlando Pacheco updated the Board of Selectmen on the following:

- Municipal Electric Aggregation Rate The Town as able to freeze the existing rate of 9.5 cents per KWH
 from June to December. TA Pacheco noted that this should provide some savings against the winter spike in
 rates.
- 2. MassWorks Grant The Town has received 10% of the funding to implement the design. However, Mr. Pacheco noted that the property owners have not committed their contributions to the project. Until they do, Mr. Pacheco is reluctant to sign any agreements that will bind the Town. He further stated that he is no moving forward with any rate studies until the Town has a better handle on the actual project and its final cost. Mr. Pacheco commented that if the Board of Selectmen would like to continue to move forward regardless of the contributions from the other parties, to please let him know.
- 3. Capital Plan TA Pacheco has started the process to develop a new long term capital plan to assist in making sure both the BOS and Fincom can better assess the Town's long term liabilities. He stated that he expects to have the requests from the departments by the end of the month.
- 4. Landfill Monitoring Mr. Pacheco has solicited quotes for Landfill Monitoring. The Town will be making the change from Tighe and Bond to Mark Popham. The will reduce the cost by 60%. He noted that the cost will drop from \$12,000 to \$5,000.
- 5. Cemetery Maintenance Assistance Town Administrator Pacheco noted that in trying to assist the Historical Commission, he reached out to the Mass Department of Corrections to see if the Town can utilize an inmate crew to assist with some of the cemetery maintenance.

VII. ADMINISTRATION, BUDGET, AND POLICY

1. Public Road Acceptance for Devonshire Way and Eagle Ridge Subdivision

Town Administrator Orlando Pacheco explained that in order to complete the public way layout process, the Town must acquire, within 120 days of the Town Meeting acceptance vote, either the fee or a permanent easement for public way purposes in the entirety of the layouts of the public ways accepted at Town Meeting. This can be done either by accepting a deed or deeds from all owners of the land within the layout, or by taking the necessary rights by eminent domain. The Town will need to know the identity of these owners. That requires title research at the Registry of Deeds. There are two options for obtaining the necessary research. (1) obtain that research on the Town's behalf, with the Town assuming the cost, or (2) the town can request that the benefitted lot owners engage counsel to obtain the necessary research and provide a certificate of title to the Town. Once the title research is complete, there will be the necessary deeds or order of taking. Mr. Pacheco is recommending is using eminent domain to ensure good title and eliminate the need to secure approval of mortgagees. Mr. Pacheco further noted that the representatives for bother Devonshire Way and Eagle Ridge Subdivision were notified about their options to proceed.

The Board of Selectmen signified eminent domain would be the better choice and asked Mr. Pacheco to continue the negotiations.
