

LANCASTER BOARD OF SELECTMEN Regular Meeting Minutes Of May 21, 2018

I. CALL TO ORDER

Chairman Stanley B. Starr, Jr. called the Regular Meeting of the Board of Selectmen to Order at 6:00 P.M. in the Nashaway Meeting Room, Second Floor, located in the Prescott Building, 701 Main Street, Lancaster, Massachusetts. Present were Selectmen Walter F. Sendrowski, Mark A. Grasso, Jr., and Town Administrator Orlando.

IV. TOWN ADMINISTRATOR'S REPORT

1. <u>Devens Household Hazardous Waste Center Audit</u>

The Devens HHW Center has completed its Audit and found no concerns for management to address with the exception of adding some additional internal controls. Town Administrator Pacheco stated that MassDevelopment does provide accounting and bookkeeping services for the organization. The FY 2018 usage of the center has remained consistent for Lancaster and many of the other member towns

2. Revolutionary War Memorial

The Historical Commission is going to move forward with placing the Monument at Middle Cemetery. Town Administrator Pacheco noted that Historical Commission is working with the DPW on some of the necessary tree removal, which should occur in the next 2 weeks. He further noted that they will then start coordinating with vendors on the monument.

3. Community Center Kitchen Project

The Community center Kitchen Project is started. Demolition has been completed, new flooring has been installed and new sheetrock placed. Anticipated completion date should be around June 15th. Mr. Pacheco commented that the Town is the Host in this project, but this is World Farmers' grant.

4. <u>Dyment Property Closing</u>

The Town has closed on the sale of the property which is located within the Town Forest. The property is listed as Book 58703 Page 119 at the Worcester Registry of Deeds.

5. Complete Streets Sidewalk Project

The complete streets project has been completed with the exception of minor punch list items. All work was completed by allied paving of Chelmsford, MA. The project is being entirely funded by the Complete Streets Grant. Planning Director Noreen Piazza stated that Allied Paving did an outstanding job.

6. MassDOT Public Hearing 70/117 Intersection

The Massachusetts Department of Transportation has scheduled a 75% design Public Hearing on design of the intersections at 70/117 which are Lunenburg Road at Main Street as well as Main Street at Seven Bridge Road. The public hearing is scheduled for Wednesday May 23rd at 7pm in the Prescott Building. The project is recommending some widening, drainage improvements, and signalization.

7. Water Line Reconstruction Work

The Water Line upgrade project is expected to start May 29th staring at the intersection of Langen Road and North Main Street (117) and move west. This portion of work is expected to take at least 8 weeks before moving to the additional areas of work.

Town Administrator Pacheco explained that after Town Meeting approved the request under Article 9 of the Annual Town Meeting Warrant, the Selectmen must request that Representative Naughton file a Special Legislation to exempt the position of Chief of Police in the Town from the provisions of MGL, chapter 31, the civil service laws.

3. <u>Discussion on Building Department Fees Schedule</u>

Town Administrator Pacheco discussed with the Board of Selectmen the Building Department fees are not at the same level as other communities, stressing the need to be competitive. The electrical fees were last addressed in 2015. Mr. Pacheco stated that residential fees will have a small increase, however the commercial side will have a larger increase, noting that the inspectors spend more time and commitment on those projects. Mr. Pacheco is requesting, as good management practice, to adopt a new fee schedule starting July 1st.

4. Discussion on Earth Products Removal Fees Schedule

Mr. Pacheco stated that it would make sense to review the earth product removal fees, noting that the Town should analyze how many cubic yards of gravel are pulled out of the ground by each earth product removal companies to determine what the rates should be. Mr. Pacheco stated that the trucks hauling the gravel, do a lot of wear and tear to the road, concern of air quality and finally the impact to real estate.
