VI. TOWN ADMINISTRATOR REPORT

1) NGRID Yearly Operational Plan

National Grid has filed its yearly operational plan which is available for review on their website. Their work for the upcoming year will be focused in North Lancaster

2) Map 10 Parcel 108D

The parcel was recently acquired by the Town via a Land Court judgment. The .04 acre parcel is assessed at \$200.

3) Old Settler's Burial Ground & Middle Cemetery

Both properties have been nominated to be on the National Register of Historic Places. The Massachusetts Historical Commission will be taking the matter up for a vote on 9/11/19 at 1pm. The Town Administrator will attend on behalf of the Town to support the designation.

4) CCC Public Hearing Requirement

There will be a meeting on Tuesday (tomorrow) at 6pm hosted by GTE with regards to their proposed Cannabis Growing Facility in North Lancaster. Both Michael Antonellis and I plan to attend

5) Thayer Field/Splash Pad

The Playground/Splash pad project is now substantially complete. The final components have been installed. Town Administrator Pacheco noted that they are filing for the final grant reimbursements now and should have all paperwork ready this week.

6) Vernal Pool Certification

The Town has had a portion of the area along Sterling Road and Deershorn Road certified as a vernal pool by the Natural Heritage and Endangered Species Program. A copy of the confirmation has been provided and forwarded to counsel if needed as part of the Goodridge Brook Estates appeal.

7) Shirley Sewer Connection Study

Town Administrator Pacheco reported that they are working with some North Lancaster landowners regarding a connection to the Shirley Sewer System and Devens Wastewater Treatment Plant, to assist with some economic development expansion. The cost of the study is being reimbursed by the property owners and should be complete in 60 days. The Study will be given to the Shirley Sewer Committee to determine if they can allow the connection and at what rates to charge for the flow.

8) ADA Self Evaluation

The Town received 3 responses to the Self Evaluation RFP. Utilizing the pricing from the selected respondent I can apply for a grant to offset the cost. We will start reviewing the RFP's for conformance immediately and should have someone selected by the next BOS meeting

9) **Police Station Drainage**

Work has started to control some of the runoff in front of the Police Station. The work should be completed this week. Earthwork and crushed stone are being added to divert water into the existing pipe.
