Present: Steven Trent, Association President

Mr. Trent said the blue-algae have been tested and it is toxic. He said they are in the beginning stage and are trying to figure out what to do about it. He said it is something that needs to be addressed.

Chairman Piazza said the Board can provide assistance getting to the right people. If the Department of Public Health says signs need to be posted we can post them. He said he contacted the Department of Public Health and he gave Mr. Trent the contact information. Chairman Piazza said he will be attending a seminar on March 5th on this subject.
