<u>Discussion, McGovern Blvd, Wastewater</u>

Mr. Bill Brookings stated that he had nothing new to report from DEP in regards to the wastewater permitting for McGovern Boulevard.

Discussion, Jones Crossing, Shared System

Present: Tyrone Jones

Chair Steve Piazza stated that Mr. Tyrone Jones sent a letter to the Board looking for some clarification on the letter the Board sent after their last meeting.

Mr. Tyrone Jones stated that he went through the Boards letter gain and was able to understand more of what the Board was looking for.

Mr. Jones stated that he reached out to Presby Company to get information regarding future cost to replace the system and they could not give him a price. Mr. Jones stated that after contacting the installer he was able to get an idea of a price to replace the system and had the cost broken down to explain how much will be place in an escrow account for maintenance and replacement of the two shared systems.

The Board had a discussion regarding the Home Owners Association and how the fees would be collected for the two shared systems and the houses that are served by them.

Mr. Jones stated that the cost estimate that he received from the installer calculations that where down for funds to go into an escrow account provide money to maintain and replace the system. Mr. Jones stated that each person on the shared systems will pay an additional fee as part of their homeowner's association fees for the systems.
