Bill Brookings said he has no issue with not requiring a deed restriction stating the fact that arsenic was in the system. John Farnsworth motioned to accept the test results and not require a deed restriction. John Ranieri seconded the motion. No discussion. VOTE: 3-0-0.

• 412 South Meadow Road- Bill Brookings said this is an upgrade. Dave Sadowski is proposing to install a presby system. There are three variances requested: 5.2-out of season testing, 6.6- lot size .3 acres and 6.2. John Farnsworth motioned to accept the plan as submitted and grant the variances as requested. John Ranieri seconded the motion. No discussion. VOTE: 3-0-0.
