- Massachusetts Office of Disability Handout. Vital records photo. Page 5:
 Disability indicator form. Page 8: silent call procedure. Page 17: summary good review of all. Workbook preparedness workbook at back of MOD? On MOD website there is a link to this workbook.
- In general, there is a lot of repetition of ideas throughout the handouts that were collected. We should include Mike Hanson's contact information in the handout as he is the designated Emergency Preparedness Manager for the Town of Lancaster.
