# <u>Public Hearing — Request for Determination of Applicability; Zero-Point Development, Inc.; Old</u> Union Turnpike

Present: Jim Basile, Hannigan Engineering, Inc., representing Applicant

Mr. Basile explained that the Subject Property is proposed to be developed with a 5 megawatt commercial solar array, and the intent is to keep the project entirely outside the Conservation Commission's jurisdiction, which includes not only the 100-Year Floodplain but also its 100-foot Buffer Zone under the Town of Lancaster Wetlands Protection Bylaw. He said the boundary of the 100-Year Floodplain shown on the Federal Emergency Management Agency (FEMA) Flood Maps for the Subject Property is wrong, so the correct floodplain elevation had to be calculated by flood modelling software from on-site topographic measurements. He said his office using this method has determined the base elevation of the 100-Year Floodplain to be 406.7 feet.

Conservation Agent David Koonce said the peer review of Hannigan Engineering's floodplain determination has been delayed by unexpected difficulties in getting all the information to peer reviewer Scott Miller, so the hearing will have to be continued to the next meeting on April 23<sup>rd</sup>.

At 7:18 PM Bonnie Smith made a motion to continue the hearing until April 23<sup>rd</sup>. James Lavallee seconded the motion. No discussion. VOTE: 6-0-0.
