The Historical Commission office space was moved in June to 94 Main Street (the Philbin Building) with the assistance of the Fire Department who used the move for training for a disaster drill. The office space in the Town Hall was required for the Town Finance Director. Thanks to the dedication of Historical Commission members and two senior tax abatement workers, the task of reorganizing and inventorying in our new office space has begun.

The Lancaster Historical Commission continues to do requested genealogy/research, Appointments can be scheduled for interested individuals to do onsite research. Copies of the books, <u>The Captive</u> and <u>The Lancastrian Towns</u> are available for sale.

The Lancaster Historical Commission voted approval of providing storage space a loan from the Lancaster Historical Society for their collections. The Commission was informed that the Historical Society has voted to pay for two slate-type markers to be placed at Old the Common and Middle Cemeteries as a gift to the Town.

The Lancaster Historical Commission supported the efforts regarding:

Prescott Building - The Planning Director, Noreen Piazza, and her team continue
work on, restore, and refurbish this historical building with grant money. Mark
Schryver, who is an architect, prepared a floor plan that the Historical
Commission approved, which was submitted to the Board of Selectmen at their
meeting. The Town Administrator compiled an RFP to hire an architect for the
project. Mark Schryver volunteered to give input regarding the selection of the
architect, and the Historical Commission has been informed that the first floor of
the Prescott Building will be its future space.

- First Church of Christ Lancaster The Commission wrote a letter of support in the church's efforts to obtain a Massachusetts Historical Commission Preservation Fund Grant. The church provided the Commission with a copy of their preservation report compiled during the work on the steeple.
- Conservation Commission The Historical Commission supported Conservation Commission member Cara Sanford on the wording for the Open Space Report by:
  - 1. Providing a timeline regarding changing uses of Lancaster's open spaces.
  - 2. Providing information about shade trees in Lancaster
- Michael Sczerzen, Lancaster Historical Chairman The Commission supported his effort to coordinate with Regonini-Zoll Memorials in Clinton for the repair and attachment of a bronze marker on the water trough at Lane's Crossing.
