Approval of Minutes

- Minutes of the September meeting were unanimously approved without any corrections.

Board of Health

- Jeff Paster provided update on dining events at the LCC as well as the upstairs kitchen which is currently occupied by World Farmer's Market.
- Jeff discussed Temperature Controlled Safety (TCS) foods as well as Limited Food Establishments (LFE) and explained these.
- Jeff reported that most dry foods prepared at homes (cookies, muffins) can be served at the LCC, but wet foods (meat, eggs) are not permitted.
- Jeff outlined the guidelines and differences for church events, home events and Town sponsored events.

Kitchen discussion:

- Kelly Dolan reported that she will be meeting with Nashoba Associated Boards of Health within the next couple of weeks to discuss the upstairs kitchen status.
- Deborah Gledhill inquired about recertification of the upstairs kitchen. Kelly reported that it will be inspected and recertified for NABH.
- Susan Munyon inquired about Safe Serve Certification and Kelly reported that Town staff will receive this certification.
- Sheila Casey expressed frustration regarding the limitations on serving food at the center and other potential venues were discussed including Bigelow Gardens.

Friends of the Lancaster Seniors

- Sheila Casey shared financial report (attached).
- The Friends will be purchasing a dishwasher for the LCC and will provide further details when available.

Department of Health and Human Services

- Kelly Dolan discussed multiple grant opportunities that the department is pursuing including a grant for a COA van.
- The new Internet Café was introduced and is available during all open hours at the LCC. There are two computers for residents to use.
- Kelly Dolan discussed Halloween on the Green activities and requested volunteers. Linda Cutler and Sheila Casey both offered to assist.
- Caitlin Roy discussed Lancaster-Giving turkey dinner grab and go program which will be on 11/16/23 at 12:00pm provided by Michael's Bridge Diner.
