# **Public Hearing, Zoning Amendment Lighting Bylaw**

At 7:05pm Chairman Lawler read aloud a Notice of Public Hearing thereby convening a public hearing for the purpose of considering amendments to Section 220-36.2 of the Zoning Lighting Bylaw. Noreen Piazza commented the bylaw hasn't changed since the last meeting.

#### Public Hearing, Zoning Amendment Recreational Marijuana Bylaw

At 7:07pm Chairman Lawler read aloud a Notice of Public Hearing thereby convening a public hearing for the purpose of considering adding a Recreational Marijuana Bylaw to the Code of the Town of Lancaster, MA, and an Article 18 to the Lancaster Zoning Bylaw, as well as an amended Section 220-8.4 (F) AND Section 220-8.4 (G) (Use Regulation Schedule).

Noreen Piazza commented since the last meeting this has been reviewed by Town Counsel with a few small changes. The proposed bylaw would allow marijuana establishments in all zoning districts except for Residential and Neighborhood Business, but would prohibit retail sale of marijuana in every zoning district. This would be a Zoning Bylaw and General Bylaw that would be voted on at Town Meeting.

Mark Finnerty, (1292 Main Street) said he heard the town would get revenues from the state. Noreen Piazza said she hasn't heard that the town could collect any revenues other than sales tax and from a host agreement.

Jeanne Rich motioned to close the public hearing. Tom Christopher seconded the motion. No discussion. VOTE: 4-0-0.

Jeanne Rich motioned to have Noreen Piazza write a favorable report concerning the general and zoning bylaw to be read at town meeting. Russ Williston seconded the motion. No discussion. VOTE: 4-0-0.

#### Public Hearing, Zoning Amendment Solar Bylaw

At 7:32pm Jeanne Rich motioned to reopen the public hearing. Tom Christopher seconded the motion. No discussion. VOTE: 4-0-0.

Katherine Holden, 322 Goss Lane came forward. She asked questions concerning fees. Jeanne Rich said Section J allows the Planning Board to waive fees.

Tom Christopher motioned to close the public hearing. Jeanne Rich seconded the motion. No discussion. VOTE: 4-0-0.

Jeanne Rich moved to add a sentence in Section J to state the Planning Board can waive fees in Section J through M. Tom Christopher seconded the motion. No discussion. VOTE: 4-0-0.

#### Discussion, Stormwater Regulations and General Permit-Scott Miller, Haley and Ward

Noreen Piazza commented that at the last Planning Board meeting the Board authorized to hire Haley and Ward to draft an amendment to the Stormwater Regulations.

Scott Miller of Haley and Ward said that if the disturbance is less than two acres then a general permit will be required by the Planning Board and the property owner will submit a letter of intent. The Planning Board will then hold a public hearing and propose conditions. He distributed a draft of the regulations, general permit, letter of intent, application checklist, and sample stormwater calculations. The public hearing will be held on May 21, 2018.
