VI. COMMITTEE UPDATES

- Win Clark spoke to the committee about the upcoming town vote on CPA. He expressed how it
 felt it would benefit the recreation and historic committees. He expressed that he would like for
 this committee to indorse CPA. After discussion the committee decided it would not vote on
 endorsement today but would revisit at a later meeting.
- Discussion on guidelines/safety measures/processes regarding potential opening of following:
 - Ball fields:
 - Matt Hourihan reviewed phase two plans for little league. A document outlining procedures was shared with committee members. The league hopes the state will move into phase three allowing the little league to begin playing games with a tentative start date of July 5, 2020.
 - Adult leagues will need to follow regulations. The recreation committee supports the state regulations. Adult leagues would need to follow the template provided by the state and posted by the recreation committee at all recreation facilities.
 - Matt Hourihan will set up a meeting with Orlando Pacheco to follow up on today's discussion.
 - Port-O-Jons will need to be ordered for fields.
 - Groups looking to rent field for baseball: Eagles from Hudson and Triple Play
 from Clinton approached Matt about renting Thayer Field. Should we do a flat

fee or daily rate? Matt will reach out to groups about potential use and schedule.
