PETITION FOR JOINT OR IDENTICAL POLE LOCATIONS

North Andover, Massachusetts

To the Board of Selectmen
Of Lancaster, Massachusetts

Massachusetts Electric Company d/b/a National Grid and Verizon New England, Inc requests permission to locate poles, wires, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public way:

Old Union Turnpike - National Grid to install 1 JO Pole on Old Union Turnpike beginning at a point approximately 235 feet east of the centerline of the intersection of Old Union Turnpike & Harvard St. Installing 1 new pole (pole 119-50 Old Union Turnpike).
